### **Terms & Conditions:**

1. The candidate must be an Indian Citizen.
2. The candidate must not be less than 18 years and more than 40 years of age as on the date of his/her submission of application. The upper age limit is relaxable by 5 years for SC/ST(P)/ST(H) candidate and 3 years for OBC/MOBC Candidates as per Govt. Office Memorandum ABP.6/2016/51 dated. 02.09.2020.
3. The minimum educational qualification is class VIII passed and candidate must hold a valid license to drive LMV/four wheeler vehicles, which is at least five years old on the date of application.
4. Filed-up "Application Form" along with Age certificate, certificates and mark sheets regarding educational qualifications, valid Driving Licence, Caste Certificate from competent authority, Employment Exchange registration certificate along with 2 (two) recent passport sized photographs **must be dropped in the "Drop Box" placed at the premise of office of the undersigned.** Candidates submitting their applications by post/courier addressed to the **Office of the Chief Judicial Magistrate, Charaideo, Sonari, Pin Code-785690, Assam** shall be received in the drop box only.
