- Sl. No.1(B.A., LL.B. /B.A., LL.B. (Hons.): Applicants should have passed the 10+2 or equivalent exam from a recognized board with a minimum of 40% aggregate marks for OBC, ST, SC candidates and a minimum of 45% aggregate marks for other category candidates.
- Sl. No.2 (LL.B.): A degree (graduation) in any discipline or any equivalent qualification from a recognized University with a
 minimum of 40% aggregate marks for OBC, ST & SC candidates and a minimum of 45% aggregate marks for other category
 candidates.

• IMPORTANT INSTRUCTIONS FOR APPLICANTS SEEKING RESERVATIONS UNDER OTHER CATEGORIES :

Applicants seeking admission under Differently Abled, Son/Daughter of permanent in-service Employees of Gauhati University, Son/Daughter of Ex-Employees of Gauhati University, Son/Daughter of Ex-Defence Personnel, Fringe Village, NCC/NSS, Extracurricular& Co-curricular Activities, etc. must apply online and take a printout of the Application Form after submitting it online. **The printed copy of the Application Form must be submitted with all required testimonials duly self-attested to the office of the Principal, University Law College, Gauhati University, Gopinath Bardoloi Nagar, Guwahati-781014, Assam in person or by post <u>on or before July 23, 2024</u>.**

• ESSENTIAL POINTS TO BE NOTED BY APPLICANTS BEFORE APPLYING ONLINE:

- 1. Applicants are required to apply online ONLY.
- 2. Each applicant must scan his/her photograph and signature, ensuring that both the photograph and signature comply with the required specifications as mentioned in the upload section of the online application process.

- 3. Signature in CAPITAL LETTERS will NOT be accepted.
- 4. Keep all the necessary details/documents/certificates ready for the documents upload section and a successful online payment of the application fee is required to submit an online Application Form.
- 5. Applicants must have a valid personal email ID and contact number, which should be kept active till the completion of this admission process. Under no circumstances, he/she should share/mention e-mail ID to/of any other person. In case an applicant does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID before applying online and must maintain that email account.

• **<u>PROCEDURE FOR APPLYING ONLINE</u>**:

1. Go to the website : https://gauhatiadmission.samarth.edu.in/

- 2. Click on the appropriate programme.
- 3. Fill up the Form, save and upload all necessary documents.
- 4. Submit the form and pay the fee in the final step.
- 5. No change to the information filled in by the applicants will be possible/accepted after the final submission of the Application Form.
- APPLICATION FEE: An application fee of Rs.1,000/- (Rupees One Thousand only) is to be paid online.

• HOW TO PAY THE APPLICATION FEE ONLINE:

Application fees must be paid through the ONLINE MODE only and other modes of payment will not be accepted. The payment can be made by using Debit Cards (Visa/MasterCard/Maestro), Credit Cards, and Internet Banking/UPI. The fee once paid is non-refundable. It is important to note that an e-receipt of application fee payment may not be generated if an online transaction is unsuccessful.

After successfully completing the online application process, applicants need to print and keep their payment ereceipt and filled-out online application form for future reference. However, the applicants seeking reservations under other categories must submit the printed copy of their application form along with other necessary documents to the office of the Principal, University Law College, Gauhati University, Gopinath Bardoloi Nagar, Guwahati-781014, Assam in person or by post during office hours in all working days <u>on or before July 23, 2024</u>, as stated in the important instructions for applicants seeking reservations under other categories.
