TERMS AND CONDITION

01. The appointment will be on Full Time Contract basis for a period not exceeding one year or till replaced by UPSC selected doctors, whichever is earlier, for the specified STATIONS only.
02. The Contract shall liable to be terminated by giving 15 days notice by either side. Without assigning any reasons, or if the Contract Medical Practitioner is mentally/physically incapacitated.
03. The administration reserves the right to place engaged CMPs anywhere in the jurisdiction of Rangiya Division.
04. The Contract appointment shall not confer any right for regularization or absorption in the post or right for continuity in service or automatic extension of the terms of contract.
05. The number of annual terms for engagement of CMPs is upto 12 terms on year to year basis or till attaining the age 65 years whichever is earlier and each term of engagement shall not exceed more than one year.
06. Not exceeding 53 years of age as on 01.10.2024. However, age relaxation is admissible to candidates belongs to SC/ST/OBC categories as per extant rule.
07. The Contract Medical Practitioner shall produce certificates of his/her character and antecedents from two gazetted officers of the Central/State Government.
08. Educational/Technical qualification: -
The candidate should be a minimum MBBS pass Degree from an institute recognized by the Medical Council of India (MCI) and with registration in MCI, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year of compulsory rotator internship.
09. Monthly remuneration:
a) For General Duty (Full time) Rs 95,000/- (PM) { The remuneration indicated against each is subject to the condition that no Govt. accommodation is provided if Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation so provided will be deducted from the monthly remuneration.
10. Those doctors who have already been engaged for 12 terms in Indian Railway need not apply.
11. Selected candidates will be subjected to medical examination and only fit candidates will be engaged as CMP.

01. The contract appointment shall not confer any claim or right for continuity in service or automatic extension of the terms of contract.
02. For retired Railway Doctors, retired Government Medical Doctors of State Governments and Central Government who are physically fit up to **65 years age as on 01.10.2024** to be considered.
03. Monthly remuneration:-
 - a) GDMO (Full time) Rs 95,000/-(PM)

{ The remuneration indicated against each is subject to the condition that no Govt. accommodation is provided if Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation so provided will be deducted from the monthly remuneration.
04. For retired Govt Medical Officer the number of terms of engagement is 10 subject to the age limit of 70 years. (In terms of Railway Board's letter No 2020/F(GR)II/1/3-Pr (1) dated 18.01.2023)
05. No Railway privilege passes/PTOs shall be admissible to Retires Doctors engaged as CMP in his/her capacity of CMP, "Duty Passes", as per eligibility would be provided for outstation duties to the CMPs.
06. **Correct information in regard to details of service as CMP in Railway in SI No 16 of the Application Format should be provided. The same will be verified through AIMS portal by linking AADHAR No., PAN Card to CMP's salary account.**
