"WALK-IN-INTERVIEW FOR ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS (CMPs) ON FULL TIME CONTRACT BASIS FOR A PERIOD OF ONE YEAR AT TINSUKIA DIVISION, N.F.RAILWAY.

It has been decided to engage "Contract Medical Practitioners (CMPs)" in Tinsukia Division, N.F.Railway from willing, eligible doctors which can be extended purely on administrative requirement and willingness of concerned CMP or till the scheme is available, whichever is earlier. A walk-in-interview will be held on **20-09-2024 (Friday)**. The details of scheme are given below:-

(The vacancies may alter as per administrative requirement at any time during the engagement. The administration reserves the right to place engaged CMPs anywhere in the jurisdiction of Tinsukia Division.)
EDUCATIONAL QUALIFICATION /ELIGIBILITY:

The candidate should be minimum MBBS pass degree from an Institute recognized by the Medical Council of India (MCI) and with registration in Medical Council of India, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year of compulsory rotational internship.

AGE: - (i) Not exceeding 53 years of age as on 01-09-2024. However, age relaxation is admissible to the candidates belonging to SC/ST/OBC categories as per extant rule.

(ii) For retired Railway Doctor, retired Government Medical Doctors of State Government and Central Government, the age to consider is 65 years as on 01-09-2024.

How to Apply: - The willing interested candidates fulfilling above conditions should report for the **WALK-IN-INTERVIEW** at **Divisional Railway Hospital, Dibrugarh , N.F.Railway , Tinsukia on 20-09-2024 (FRIDAY) at 10-00 hrs** with application duly filled/signed as per the enclosed format along with copies of all certificates/testimonials in original and attested true copies and also two passport size photographs.

Selected candidates will be required to produce the original certificates, and self attested photocopies of all the certificates showing date of birth/educational qualification /community, four passport size photographs, original copy of PPO(Pension Payment Order)/ Service certificate / Last Pay certificate (in case of retired doctors) at the time of joining/engagement.


In the event of wrong information/fake academic certificate/ testimonials etc, the candidate will be liable to be taken up under Government of India law in force.

OTHER TERMS AND CONDITIONS:

- (i) The appointment will be on full time Contract basis for a period not exceeding in one year or till replaced by **UPSC selected doctors** , whichever is earlier . He/She can be transferred to any station within the jurisdiction of TSK Division for administrative interest.
- (ii) Selected candidate as CMP against the vacancy of Railway Mobile Medical Van will be required to move and travel on Road Mobile Van to perform duties.
- (iii) Selected candidate will be subjected to medical examination and only fit candidates will be engaged as CMP.
- (iv) The contract Medical Practitioner shall produce certificate of his/her character and antecedent from two Gazetted officers of Central/State Government.
- (v) OBC candidates should submit a proper '**Non-creamy layer**' certificate.
- (vi) The Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the terms of contract.
- (vii) The number of annual terms for engagement of CMPs is maximum **12** terms on year to year basis or till attaining the age of 65 years whichever is earlier and each term of engagement shall not exceed more than one year. For retired Govt. Medical officer, the number of terms of engagement is 10 subject to the age limit of 70 years.
- (viii) For retired Railway Doctor, retired Government Medical Doctors of State Government and Central Government, the monthly remuneration as decided by Railway Board, is subject to the condition that the pension plus contractual remuneration of the Retired Doctor should not exceed the last pay drawn at the time of retirement. No Dearness and any other allowance which are admissible to regular Railway servants shall be admissible.
- (ix) During the validity of contract, the CMP will be at liberty to terminate the contract for betterment his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by Railway administration if the CMP is found to be mentally or physically incapacitated.
- (x) Engagement of CMP will not confer any right for automatic regularization or absorption in Railways. The detailed instructions with regard to the duties while in contract with Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
- (xi) Appearance in the interview will not vest any right upon the candidate to be engaged as CMP and no reason will be cited or communication shall be made with the candidate in the event of the candidate not getting selected.
- (xii) In case a railway accommodation is provided to the CMP, an amount equivalent to sum of HRA and license fee of the accommodation so provided shall be deducted from the monthly remuneration.
- (xiii) The Railway Administration reserves the right to cancel this notification without assigning any reason(s).
- (xiv) No Railway privilege Passes/ PTOs shall be admissible to CMP. However, "Duty Passes", as per eligibility would be provided for outstation duties to the CMPs.
- (xv) Those doctors who have already been engaged for 12 terms in Indian Railway need not apply.


