NOTE:

- 1. The upper age limit in respect of Scheduled Castes, Scheduled Tribes, Ex-Servicemen and other special categories of persons etc. shall be relaxable in accordance with the orders issued by the Government of India from time to time.
- 2. *Unless otherwise indicated in the recruitment rules, age relaxation as mentioned for personnel serving in Central/State Government and Autonomous Institutions of Central & State Govts. and for regular employees of AIIMS who have completed three years of regular service period will be allowed. This clause is not applicable to AIIMS, New Dehi or it may not also be applicable to any other participating Institute if expressly notified on website.
